

Dear Volunteer,

In order to better inform our volunteers of district practices and policies, and to protect the safety and security of our students, the Board of Education has instituted the policy on volunteers in our schools (Policy 4532) which can be found on the district website. As part of this, all Rye Neck volunteers will be required to complete a volunteer application form. We recognize the importance of the community-school partnership and believe these steps will both strengthen our volunteer program and further our continuing efforts to provide a safe environment for our students.

Your completed volunteer application form must be on file before you can begin volunteer activities for the 2023-2024 school year. You only need to complete just **one** form regardless of the number of children you have in the district or the number of schools in which you plan to volunteer. As many of you did last year, simply return your form to any principal's office or directly to my office. Volunteer information will be kept **confidential**, with forms being maintained only in the central office and **shredded** at the end of each school year. Building principals will be provided with a listing of volunteers and only volunteers from the approved list will be used.

In an effort to ensure that you, students and staff have a positive experience, please follow these guidelines when volunteering:

- Treat everything you see or hear regarding students or staff as confidential.
- Never be alone with students or use student bathroom facilities.
- Review the emergency drill procedures for the buildings in which you volunteer.
- Treat all members of our school community with respect.
- Sign in and out at the school office and wear your volunteer badge at all times while in the building.
- Always consult with the staff member you are volunteering with before initiating an activity.

Applications can be completed now for next year's volunteer service. The Volunteer Application has been updated to include a Hold Harmless Agreement which is required by our insurance carrier. Please take a few moments to complete the attached application and return it to the central office. Forms may be completed and returned anytime during the year, but know that applications will have to be reviewed before individuals will be allowed to participate. Thank you for your time and commitment as a Rye Neck volunteer.
